- Mr. Turley presented PY22 BAR #1.
- Bar #1 is based on the NMDWS allocation letter dated 7-1-22 and our known actual carryin from PY21.
- BAR # 1 updates the prelims estimated carry-in of \$2,472,000 to actual formula carry-in of \$2,837,636. It is made up of Adult, Dislocated Worker, Youth and Administrative Dollars.
- BAR #1 lowers Ticket to Work and DW NEG Grant funds available.
- BAR #1 adds the USDOL Changes Grant to the WCCNM's Budget of \$1,999,999. Starting on July1, 2022 to December 31, 2025.
- Total WCCNM Budget is 414,684,673.

- The Waiver will include the following:
- NMAC 11.2.4.7 A. CEO Definition was amended to narrow the definition and recognition of WIOA Chief Elected Officials to one county representative from each of the County Commissions.
- The WCCNM CEOs are reluctant to adopt this definition for the WCCNM CEO Board due communities and reduce participation of CEO Board members that have been active participants in the governance and within the operation of the WCCNM's Workforce System.
- This waiver is requesting that the NMDWS allow representative of each County Commission and the Mayors of municipalities and villages (those that sign the CEO Agreement) as recognized members of the CEO Board.
