WCCNM Youth Standing Committee Charter

Purpose

The Youth Standing Committee will review and make recommendations to the Executive Committee on matters related to WCCNM's youth provider program and other youth related projects and initiatives.

Youth Standing Committee Mission:

The WCCNM Youth Standing Committee is committed to assist with planning, operational, performance and other issues related to the provision of youth services. WCCNM's Youth Standing Committee assists local communities to identify gaps in services, recommend youth policy, ensure quality services, leverage financial and programmatic resources and recommend eligible youth service providers.

Membership

The WCCNM Board will appoint the committee chair, co-chair, and members and each will serve a term of one year and may be renewed on an annual basis. The board may fill vacancies on the committee and may remove a member from the committee at any time without cause.

The committee shall have a minimum of three members. The committee is open to nonmembers of the WCCNM.

Authority

The Youth Standing Committee works with the WCCNM Administrative Entity to identify and respond to events and issues involving the WIOA Youth program and other youth related projects and iniatives.

The Youth Standing Committee provides recommendations to WCCNM Chief Elected Officials, WCCNM Full Board, and Executive Committee.

Responsibilities

The Youth Standing Committee will report its activities to the board at least on a quarterly basis. Areas of responsibility include, but are not limited to:

- Review and study youth issues within the Central Region.
- Identify priorities for Central Region youth development programs which align with the WCCNM 4-Year Plan and provide a positive youth development experience.
- Recommend continuous improvement plans of action to fulfill the priorities.
- Review the year's program activities and events in the Central Region.
- Assess successes and future needs.
- Assist in the development of regional policies, rules, and regulations.



Meetings

The Youth Standing Committee will meet at least quarterly and more often as needed. A majority of the committee members shall constitute a quorum. The committee chair may invite any director, officer, staff member, expert or other advisor who isn't a member of the committee to attend, but these individuals have no voting power.

The committee will review its charter at least biannually and recommend any proposed changes to the board for review.

Success Stories:

Torrance:

Lucian, 22, came to the Workforce Connection office in Moriarty in December 2021, hoping to receive financial assistance in order to attend the Central New Mexico Community College Law Enforcement Academy so that he could become a Law Enforcement officer. Lucian was enrolled in the WIOA Youth Program on 12/22/21. Lucian ended up having to wait until January of 2023 to attend the Law Enforcement Academy. Lucian successfully graduated from his CNM Law Enforcement Academy on Thursday, May 18, 2023. Below is photograph of Lucian at his graduation ceremony.



Sandoval:

Brionna is a 21 year old female that came into our program needing assistance to further her education in order to support herself. Brionna graduated from high school and had aspirations of being in the medical field. Brionna came to WIOA last year around this time and was interested in starting school with PIMA for a Medical Assistant certificate. Brionna was able to achieve exemplary grades and graduated from PIMA January 19, 2023 with her certificate in Medical Assisting. Brionna completed her clinicals with Southwest Integrative Health. Because of her hard work and dedication she was able to obtain a full time position with Southwest Integrative Health. Brionna continues to show her dedication to her future and her hard work is paying off by attaining full time employment

Bernalillo:

19 year-old Joshua joined the WIOA Youth Program in March of 2023. He qualified for the program as basic skills deficient and low income.

When he enrolled in the program, he stated that he wanted to get experience and education in the construction field to better the lives of himself and his family.

Joshua participated in the Fortis Hard Hat in Hand program where he completed education and on-thejob training. Through WIOA he was able to receive supportive services reimbursements for tools and steel-toe boots. Since completing the program he is currently working for Western Partitions Inc (WPI) at the Los Lunas Data Center. His goals include becoming a journeyman, a foreman, and possibly a superintendent in the construction industry so that he can provide for his family as well as to build his own house with the knowledge he is gaining from his construction career.
